Carrion asked for a motion to accept the presentation and vote to move forward with the submission of the high school to the NYC DOE. Ms. Rojas accepted the motion and Mr. Corwin seconded the motion. A vote was held, and it was a unanimous vote in favor of the high school application. Ms. Jackvony shared the various groups who have written a letter in support of the BAOP high school.
